

Subject: **Sanction of Ex-Bangladesh leave.**

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh (GoB) of Ex-Bangladesh leave from 11/02/2018 to 12/03/2018 or 30 (thirty) days from the date of departure in favour of Mr. Md. Nazmul Islam Bhuiyan, Manager, Bangladesh Export Processing Zones Authority (BEPZA) along with his wife Ms. Sultana Jannat for visiting India for treatment and visits to religious places under the following conditions:-

- (a) While visiting India and on journey to and from, he will be treated as 'on duty';
  - (b) He will bear all expenses of the tour from his own fund. BEPZA or GoB does not have any financial involvement in this regard.
  - (c) He will not stay abroad beyond the sanctioned period of leave;
  - (d) Pay and allowances will be payable in local currency and no part of it shall be drawn in foreign currency.
  - (e) In the sanctioned leave, 15 (fifteen) days will be his rest and recreation leave which has been approved before and the rest will be Ex-Bangladesh leave (earned leave).
